GENERALITIES CONCERNING ALL DISCIPLINES

WHO DOES IT CONCERN?

This document is intended to help Continental Confederations, National Federations and organisers with the registration of the following season's competitions on the international calendars, for all disciplines:

WHAT IS THE PURPOSE?

For any organiser planning a cycling competition, one of the key obligations is to have that competition officially included on the **UCI International Calendar**. This is not simply an administrative formality: without registration, a competition will not be recognised as an official UCI event.

Under UCI Regulations (Articles 1.2.001 et seq.), organisers are required to submit a registration request each year to their National Federation, who will in turn forward it to the UCI for approval. The UCI Management Committee has final authority over the composition of the UCI International Calendar, acting on the advice of the Continental Confederations for competitions falling within their remit (Articles 1.2.005–1.2.006).

HOW IS THE REGISTRATION DONE?

The UCI has introduced **UCI DataRide v2** as the official online platform for all calendar registration requests. It is now the central workspace for submitting, tracking, and updating your competition's registration replacing any previous PDF or email-based process.

All parties involved in the process (Organisers, National Federations, and Continental Confederations) must hold an active UCI DataRide v2 account to register a competition.

REGISTRATION REQUEST

Depending on the situation, organisers will find one of two options:

- **Competition held in the previous season:** A pre-filled registration form will already be available, based on the existing competition details. The organiser reviews and updates the information as needed.
- **New competition:** A new entry request can be submitted directly through the platform.

VALIDATION BY YOUR NATIONAL FEDERATION

Once submitted, the registration request is sent to the relevant **National Federation** for review and validation. The National Federation checks that everything is in order before forwarding the request to the UCI.

Where a competition falls within the remit of a **Continental Confederation**, it acts as an additional validation step between the National Federation and the UCI.

The status of a registration request can be tracked at any time directly within UCI DataRide v2.

UCI DataRide v2 provides all stakeholders with a real-time overview of the calendar relevant to their level: organisers can view their own competitions, National Federations have visibility over all competitions registered within their country, and Continental Confederations can monitor all competitions taking place within their confederation.

In addition to this level-based visibility, UCI DataRide v2 also provides all stakeholders with access to the **UCI International Pre-Calendar — Global View**.

This read-only overview displays all competitions worldwide for the upcoming season. It is intended to help each party select competition dates under the best possible conditions, avoid conflicts with other competitions, and ensure compliance with UCI regulations.

This new feature represents a significant step towards greater transparency across the cycling community.


Please note that the dates displayed in the Global View are not yet confirmed. They represent proposed dates that will be submitted to the UCI Management Committee for final approval.

The calendar therefore remains subject to change until officially confirmed.

HOW TO GET ACCESS TO UCI DATARIDE V2?

Access to the platform is required for all organisers, National Federations and Continental Confederations involved in the registration process.

EXISTING ORGANISERS

Organisers who held a competition registered on the UCI International Calendar in the previous season will receive an access invitation directly from the UCI Sports Department at the beginning of the registration period.

This invitation will be sent to the contact email address on record. Simply follow the instructions in the email to activate your account and log in to the platform.

NEW ORGANISERS

Organisers wishing to register a new competition for the first time must contact their National Federation to request access to UCI DataRide v2.

The National Federation will review the request outside of the UCI platform process.

If approved, the National Federation — who are the only ones entitled to grant access to a brand-new organiser — will send the organiser a link to complete a new organisation creation form in the UCI database.

This approval step is essential to avoid duplicate entries and ensures a first-level verification of all new organisations in the UCI database.

Once the organisation has been created and validated, access credentials to UCI DataRide v2 will be provided to the designated contacts of that organisation.

NATIONAL FEDERATIONS AND CONTINENTAL CONFEDERATIONS

National Federations and Continental Confederations already have access to UCI DataRide v2 in their capacity as validators of the registration process.

In addition, National Federations act as organisers for their respective National Championships and Continental Confederations act as organisers for their respective Continental Championships. In both cases, they access the platform in their organiser capacity to submit and manage the registration of these competitions, following the same process as any other organiser.

ONCE LOGGED IN

Once logged in, each stakeholder has access to a personalised overview of the Calendar relevant to their level:

- **Organisers** can view and manage their own competition registration forms.
- **National Federations** have visibility over all competitions registered within their country and are responsible for validating submissions before they are forwarded to the UCI. They also manage the registration of their National Championships directly as organisers.
- **Continental Confederations** can monitor all competitions taking place within their confederation and act as an additional validator where required. They also manage the registration of their Continental Championships directly as organisers.

WHAT YOU NEED TO KNOW BEFORE COMPLETING YOUR REGISTRATION FORM

The registration form is completed directly in UCI DataRide v2. All fields must be completed accurately and in full, as incomplete submissions may be returned to the organiser for correction.

COMPETITION NAME

The competition must be registered under its official name. Any request for a name change must be made directly in UCI DataRide v2 in the relevant field. In accordance with Article 1.2.015, an organiser cannot call a competition by any name other than that under which it was registered on the calendar.

The National Federation is responsible for verifying that the requested name does not belong to a third party (Article 1.2.016).

DATES

Draft calendars available in UCI DataRide v2 is provided for information only.

The proposed dates are based on the broader competition landscape and are intended to suggest the most suitable placement for your competition within the season. The organiser must confirm the dates of their competition by submitting the completed registration form through the platform.

CHANGE REQUEST

Any request for a change of date must first receive the approval of the National Federation before it can be processed by the UCI. To submit a change request, the organiser must log in to UCI DataRide v2 and initiate the request directly through the platform. A written justification is mandatory and must be uploaded in the "Supporting Documents" section of the form at the time of submission.

Once the change request has been submitted, the validation process will restart for the relevant section from the beginning. The National Federation will first review and validate the request, followed by the Continental Confederation where applicable, before it is transmitted to the UCI for final authorisation. In accordance with Article 1.2.014, any change of date requires prior authorisation from the UCI.

The UCI reserves the right to modify dates in order to avoid conflicts between competitions that may be unfavourable to cycling.

For UCI WorldTour competitions, authorisation of any date change is granted by the Professional Cycling Council. For all other competitions, the National Federation acts as a validator in the process. Organisers are encouraged to consult their National Federation before submitting any change request to expedite the validation process.

Please note that in the event of an unauthorised date change or a cancellation, the organiser shall be liable for a fine or an additional fee, the amount of which is set annually by the UCI Management Committee (Article 1.2.014).

NEW COMPETITIONS

Organisers wishing to register a new competition must log in to UCI DataRide v2 and navigate to the Calendar module. From there, click on "**Create a new request**" and select the relevant season year, discipline and class for which you wish to apply.

The completed form will be submitted to the National Federation for validation in accordance with Article 1.2.009. The form must include the following information:

- Competition Name
- Proposed dates of the competition
- Contact details of the organiser and main contact person
- Type of competition (discipline, class, rider category, event type)
- Venue, city and country
- Technical Guide with the following information :
 - description of the course including total length (in km) and, where applicable, that of stages and circuits
 - Envisaged number and categories of participating teams and/or riders
 - Financial aspects (prizes, travel and subsistence expenses)
- Supporting documents
- References concerning organisation
- Confirmation that the competition shall be held in accordance with UCI regulations for the discipline concerned

Please note that new competitions may only be given the lowest class status in their first year, subject to UCI review and approval by the UCI Management Committee.

UCI INTERNATIONAL CALENDAR REGISTRATION PROCEDURE

ORGANISER LICENCE

In accordance with Article 1.2.031, the organiser of a competition must hold a valid UCI licence issued by the National Federation of the country where the competition takes place.

It is therefore essential that the person in charge of the organisation holds a UCI ID and is registered through the UCI Licence module in [UCI DataRide v1](#) prior to submitting any registration request.

Note: as the Licence module has not yet been developed on UCI DataRide v2, licence requests are currently handled on UCI DataRide v1.

VALIDATION AND COMMITMENT

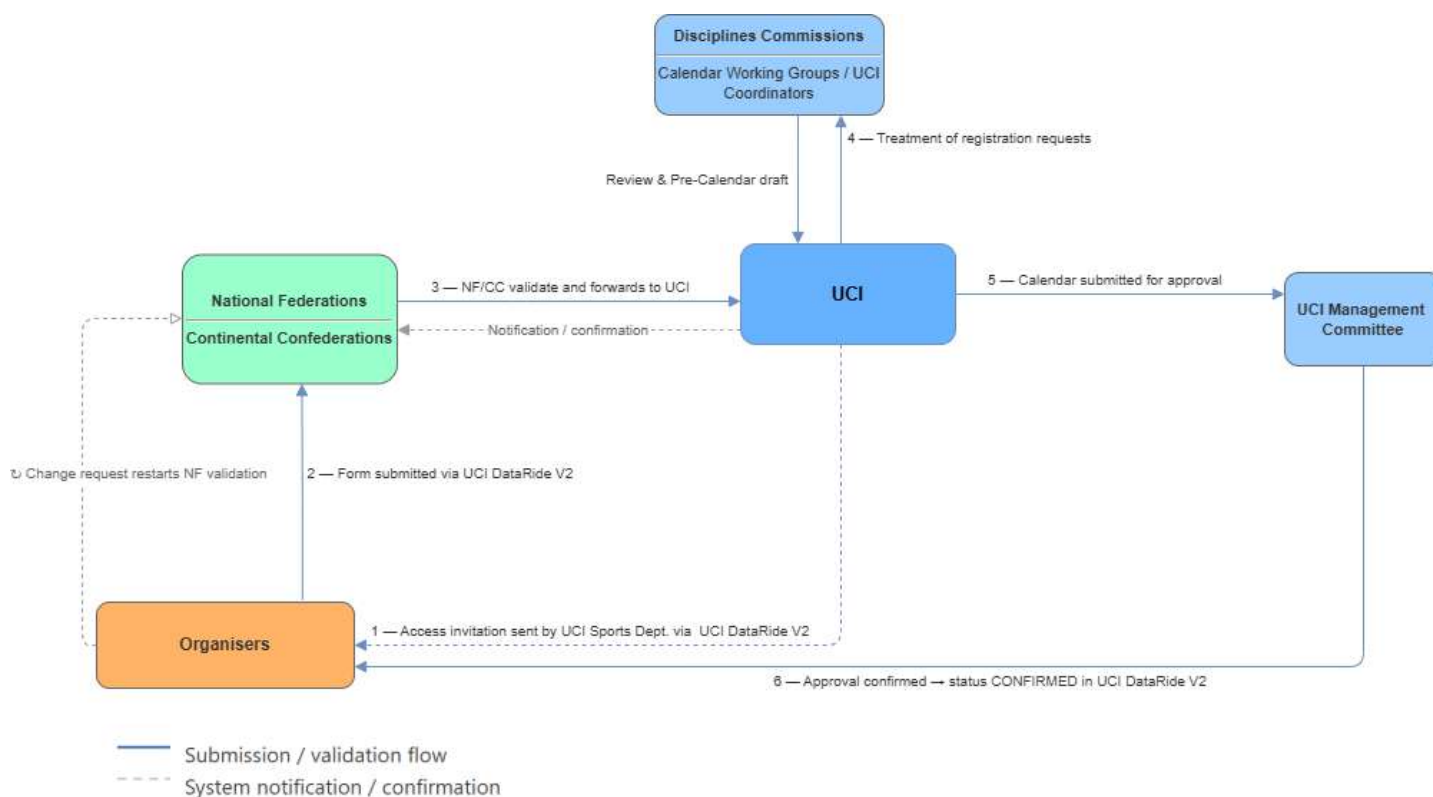
By submitting the registration form through UCI DataRide v2, the organiser formally commits to respecting the UCI Constitution and Regulations (Article 1.2.006). The digital submission replaces any previous written or signed validation process.

Each registration must be reviewed and approved by the National Federation within UCI DataRide v2 before it is transmitted to the UCI.

Submissions that do not comply with the requirements set out in the UCI Regulations and registration procedure will be returned to the organiser for correction through the platform.

If a competition takes place across the territory of several countries, it may only be registered on the calendar with the agreement of the federation of each country concerned (Article 1.2.006).

SUMMARY OF THE PROCEDURE



STEP 1: ACCESS TO UCI DATARIDE V2

From this year onwards, organisers who held a competition registered on the UCI International Calendar will receive directly from the UCI Sports Department an access invitation to the UCI DataRide v2 platform, where they will find a pre-filled registration form based on their competition details from the previous season.

STEP 2: COMPLETING THE REGISTRATION FORM

Organisers who held competitions the previous year must check, complete the pre-filled form for their competition(s) and submit to their National Federation in order to confirm the registration.

In the case of a new organiser, they must contact the National Federation of the country/ies in which the competition takes place to obtain access to the UCI DataRide v2 platform.

STEP 3: SUBMISSION DEADLINES

The deadlines set out in **Article 1.2.006** of the UCI Regulations apply to National Federations for the transmission of registration requests to the UCI. They are as follows:

To allow the National Federation enough time to review and validate registration requests before these deadlines, organisers must submit their online registration form to their National Federation **at the latest 3 weeks before these deadlines**. Further information about this procedure is detailed in the step-by-step guide available in this folder: [DOCUMENTATION](#)

Compliance with these deadlines is essential to enable the UCI Sports Department to submit the UCI International Calendars to the UCI Management Committee on time.

STEP 4: REVIEW BY THE UCI

The UCI will review all registration requests and draw up the calendar for the upcoming season. Once a submission has been validated at this stage, an email notification will be sent confirming that the registration form has been completed and will be submitted for final approval to the UCI Management Committee.

STEP 5: APPROVAL BY THE UCI MANAGEMENT COMMITTEE

The calendar for the following year will be presented to the UCI Management Committee for approval.

STEP 6: PUBLICATION

Once approved by the UCI Management Committee, the calendar will be published on the UCI website on the first working day following the meeting. All organisers will be notified through the platform, and their competitions will be updated to the status **CONFIRMED**.

COSTS

UCI FINANCIAL OBLIGATIONS

The UCI establishes, for each calendar and each Competition Class, a range of calendar fees as well as participation allowances and prize money. These amounts are described in the UCI Financial Obligations.

You will find [hyperlinks](#) to the UCI financial obligations for each discipline in the relevant sections later on in this document.

ECONOMIC CLASSIFICATION

The amounts of calendar fees and prizes will be adapted based on the economic situation of the country. Therefore, reference should always be made to the coefficients of the Economic Classification of the countries. This Classification could be reviewed during the year.

RIGHT TO REGISTER

The registration fee of every competition is subdivided into 2 parts:

1. UCI Calendar Fee

In compliance with **Article 1.2.012**, the inclusion of a race on the UCI international calendar shall be subject to the payment of a fee, called the calendar fee, the amount of which shall be set annually by the UCI Management Committee.

This fee includes allowances (expenses and travel) for officials (International Commissaires and Doping Control Officers) appointed by the UCI and enrolment fee for each competition on the international calendar. The accommodation expenses (room + breakfast) remain payable by each organiser. The total amount of these fees must be paid in Euros, within the deadlines described in the **Article 1.2.012**. The UCI reserves the right to remove the race from the international calendar at any moment prior to the event should the calendar fee remain unpaid.

2. Annual Anti-Doping Contribution

The annual anti-doping contribution can be found in the UCI Financial Obligations published on the UCI Website at [this link](#).

PAYMENT

The total amount of the fee must be paid by the organiser to the UCI upon reception of an invoice from the UCI. Invoices are sent 90 days before competitions, or upon approval of the competition in the calendar, whichever is later.

REGISTRATION REFUSAL

The inclusion of the competition on the calendar **shall be refused if the previous year's fee as well as the penalty, have not been paid one month prior to the meeting of the Management Committee** at which the calendar in question is approved.

Furthermore, a competition registration shall be refused if the enrolment fees for previous competition have not been paid or if the organiser does not honour its financial obligations with the UCI. This measure also applies to the new organiser of the race and, in general, to the organiser and/or competition that the UCI Management Committee considers to be the successor of another organiser or another race (**Article 1.2.012**).

INVITATION - ENROLMENT

In accordance with **Article 1.2.048**, without prejudice to the provision concerning Mountain Bike, BMX Racing and BMX Freestyle, Indoor Cycling, Para Cycling, Cycling for All, Track and the Masters category, organisers of competition registered on the international calendar are not allowed to demand from riders and/or teams any participation fee whatsoever (contribution to expenses, registration fees, etc).

OTHER ITEMS

NATIONAL CHAMPIONSHIPS

As of this season, National Federations are directly responsible for registering their National Championships through UCI DataRide v2, acting as organisers. This applies regardless of whether the National Federation is the physical organiser of the competition or whether the organisation on the ground is delegated to a third party. This approach mirrors the process applied to Continental Confederations for the registration of Continental Championships, placing each entity in full ownership of the registration of the competitions that fall under their jurisdiction.

As stated in Article 1.2.029, National Road Championships shall be raced during the last week of the month of June. However, the UCI Management Committee can decide to move this week back or forward due to major events (e.g. the Olympic Games).

- National Cyclo-cross Championships shall be run on the date approved by the UCI Management Committee.
- National Mountain Bike Championships XCO and XCC shall be run on the third weekend of July. National Mountain Bike Championships for other formats can be organised at a different date than the mandatory date.
- National BMX Racing Championships shall be run on the first weekend of July.
- National Trials Championships shall be run on the last weekend of June.
- National Indoor Cycling Championships should take place in principle 4 weeks before the UCI World Championships.

The UCI may grant dispensations for the southern hemisphere or in cases of force majeure. It is highly advised not to register any other competition during those periods.

CONTINENTAL CHAMPIONSHIPS

As of this season, Continental Confederations are directly responsible for registering their Continental Championships through UCI DataRide v2. Acting in their capacity as organisers of their own Continental Championships, Continental Confederations must log in to the platform, complete the registration form in the Calendar module and submit it directly to the UCI Sports Department — no later than **1st June** for all disciplines.

This approach mirrors the process applied to National Federations for the registration of National Championships, placing each entity in full ownership of the registration of the competitions they organise.

For Track, Continental Championships (Men Elite and Women Elite) shall take place in February. The UCI may consider a request for exemption for the seasons outside of the Olympic qualification period. Such request must reach the UCI during the calendar registration period of the competition.

CLASSIFICATIONS AND CUPS

Please note that, according to **Article 1.2.026**, National Federations, their affiliates and licence holders and, in general, all bodies answerable to them shall be barred from participating actively or passively in any individual or team classification based on the competition on the UCI international calendar other than those drawn up or expressly authorised by the UCI. Competitions conducted by an organiser who fails to comply with the preceding paragraph shall be deleted from the international calendar for the following year.

SPONSORS - GENERAL RULE

To ensure the integrity and image of cycling, the UCI has identified several categories of sponsors with whom stakeholders, including organisers, may not be associated (directly or indirectly). Thus, **Article 1.1.089** of the UCI Regulations provides that:

"Without prejudice of the applicable law, no brand of tobacco, spirits, pornographic products or any other products that might damage the image of the UCI or the sport of cycling in general shall be associated directly or indirectly with a licence-holder, a UCI team or a national or international cycling competition.

As defined in the present article, a spirit is a beverage with a content in alcohol of 15% or more."

In addition, **Article 1.1.090** of the UCI Regulations lays down certain conditions in relation to sponsorship by **betting companies** (including national lotteries). These conditions protect the integrity of cycling by reducing the risk of collusion and ensuring that visibility on cycling events is exclusively granted to betting operators whose activity does not cause a risk to the integrity of the sport.

The organiser seeking sponsorship by a betting company shall provide documentation establishing compliance with the conditions laid down in **Article 1.1.090** of the UCI Regulations with its request for registration before the UCI (the same applies in case the sponsorship is considered after the registration has been confirmed). We invite you to read this article carefully and remain at your disposal.

FORBIDDEN COMPETITIONS

Article 1.2.019

No licence holder may participate in a competition that has not been included on a national, continental or world calendar or that has not been recognised by a National Federation, a Continental Confederation or the UCI.

Depending on the circumstances, a National Federation and the UCI may grant special exceptions for particular races or events run in its own country.

Particular competitions or events may consist of:

- Events organised occasionally only and which do not belong to the organised sports movement;
- Events whose format is not covered by the UCI regulations.

Any National Federation intending to grant a special exception must submit its reasoned request to the UCI administration at the beginning of the season and at least

two months before the competition in question. The decision of the UCI is final and shall not be subject to appeal.

CLASSIFICATION AND REFUSAL OF THE REGISTRATION OF A COMPETITION ON THE UCI INTERNATIONAL CALENDAR

The UCI Management Committee, the Professional Cycling Council and the UCI Road Commission reserve the right to change the classification of competitions or to refuse the registration of competitions based on the level of participation, the quality of the organisation of races, the compliance with the UCI Regulations and Financial Obligations. The final approval for the calendar will be given at the UCI Management Committee meeting taking place in September.

HOW MUCH DOES IT COST FOR ROAD?

FINANCIAL OBLIGATIONS

The Road financial obligations are published on the [UCI website](#) with the amounts regarding calendar fees, the anti-doping contribution, participation allowances, prize money and additional fees in case of a late registration or a date change during the season.

ROAD CALENDAR REGISTRATION: DISCIPLINE-SPECIFIC REQUIREMENTS

COMPETITIONS OF THE BEGINNING OF THE SEASON (i.e. between the 19 October and the 31 December 2026)

The date limit to complete the registration form for the competitions of the beginning of the season, to the UCI is **20 May 2026**. The registration of these specific events will be submitted for approval to the UCI Management Committee in June.

UCI PROSERIES CALENDAR

As a reminder, the 2026-2028 registration cycle for the UCI ProSeries Men Elite and Women Elite calendar is closed and will not accept new applications. The deadlines set out in **Article 1.2.006** must be respected. As a reminder, **Articles 2.18.006 to 2.18.009** detail the elements and criteria for the eligibility of events on the UCI ProSeries calendar.

UCI WORLDTOUR CALENDAR

The UCI WorldTour calendar is established by the Professional Cycling Council and proposed to the UCI Management Committee for approval on a yearly basis, in consideration of the criteria set out in the UCI Regulations, in line with the provisions in **Part II, section XV**. It has a separate and proper registration procedure and is published in June.

UCI WOMEN'S WORLDTOUR CALENDAR

The UCI Women's WorldTour calendar is established by the Professional Cycling Council and proposed to the UCI Management Committee for approval on a yearly basis, in consideration of the criteria set out in the UCI Regulations, in line with the provisions in **Part II, Chapter XIII**. It has a separate and proper registration procedure and is published in June.

SPECIFIC INSTRUCTIONS FOR UCI MEN JUNIOR NATIONS' CUP AND WOMEN JUNIOR NATIONS' CUP

For organisers of UCI Men Junior Nations' Cup and Women Junior Nations' Cup, please consider the specific instructions detailed hereafter.

Organisers of competitions wishing to be considered for the UCI Men Junior Nations Cup and UCI Women Junior Nations Cup are kindly requested to read carefully the specific instructions detailed on the following pages.

A new format for the UCI Road Junior Nations Cup is currently being finalised and will shortly be submitted for approval by the UCI Management Committee. Organisers will be notified as soon as this validation has been confirmed.

At present, all the Men Junior and Women Junior competitions are listed under Class 1 status. Competitions wishing to be part of the UCI Road Junior Nations Cup will be required to meet specific criteria, which will be set out in a dedicated specification document to be published in the near future.

Competitions seeking to apply for the UCI Road Junior Nations Cup will need to comply with the requirements defined in this specification document. The document will outline in particular the eligibility conditions, organisational standards, and application procedures. A selection of events will then be made on the basis of the criteria and processes detailed therein.

SUBMISSION OF THE REGISTRATION FORM

Candidates are required to submit the registration form of their event **no later than by 1st July 2026**.

DRAFT CALENDARS

Draft calendars are available directly on the UCI DataRide v2 platform when clicking on "Calendar view". Existing events have been included in the draft calendars with the dates generally based on the previous season but also taking into account the specific elements of the 2026 season. Detailed information is restricted to competitions under your organisation's jurisdiction. National Federations have full visibility into all competitions within their country, while all other competitions display limited details only.

ORGANISERS' RIGHTS

- All marketing and sponsorship rights for the title and format of the UCI Nations' Cup are the exclusive property of the UCI. The UCI grants the organiser the marketing and sponsorship rights for its race, apart from the rights for the "presenting sponsor" for the for the UCI Nations' Cup series, which remain the property of the UCI.
- The UCI is the exclusive owner of worldwide broadcasting rights for the event in the widest sense of the term (including without limitation radio, television, the internet, telephone, wireless and any and all existing or future multimedia rights). The UCI will assign these rights to the organiser.
- Use of the UCI Nations' Cup label according to the UCI Visual Identity Guidelines, that are available [on this link](#).

IDENTITY OF THE EVENT

Respect of the visual guidelines of the UCI Nations' Cup on the race infrastructure: finish/start arch, podium, flash interview. The visual guidelines of the UCI Nations' Cup are available [on this link](#).

The organiser promises to respect the obligations mentioned if his race is selected for the 2026 UCI Nations' Cup.

CRITERIUMS

For Criteriums, please refer to **Part II, Chapter VII** of the UCI Regulations.

SPECIFIC INSTRUCTIONS

This calendar is the responsibility of the federations and is reserved for events raced on a circuit of less than 10 kms. **Organisers whose criterium is not included on this calendar may not invite riders from a team registered with the UCI or allow them to ride.** In addition, to allow the participation of a rider registered with a UCI WorldTeam or a UCI Women's WorldTeam, Criterium events must pay, **as per art. 2.7.005bis**, a registration fee of € 1000.

OTHER RACES

SPECIFIC INSTRUCTIONS

Events that have a format that does not comply with the UCI Regulations in Part II, Chapters III to VII may submit their registration as "other races" (**art. 2.9.001** and following). These events can still be registered on the UCI International Calendar provided that they observe a certain number of conditions and other provisions of the UCI Regulations. They benefit of a registration as a Class 1 or Class 2, as per the categories below.

- **One-day event** (with special format): 1.1S or 1.2S
- **Stage event** (with special format): 2.1S or 2.2S

SPECIFIC INSTRUCTIONS FOR THE UCI INTERNATIONAL TRACK CALENDAR

CLASSIFICATION

The class of the competition determines the points awarded to the participants as per the scale stated in the UCI regulations (**Title III, Chapter III**).

As a reminder, it is possible to specify on the registration form the type of class (Class 1, Class 2, Nat) for each event. The events at a national level (Nat.) can be registered as a complement to the UCI competitions.

The evaluation of the competitions registered in the 2026 calendar determines the class in which they will be registered for the 2027 season (as per **art. 3.8.003**).

Any event for which points counting for the UCI Track Ranking are awarded will need to respect the formats and/or minimal distances as stipulated in the UCI Regulations, failing this, points will not be awarded.

With regard to the minimum criteria for **categories**, if several categories participate in the same event, the category of the majority of participants will be taken into account only.

Younger athletes (minimum 17 years old, 1st year junior) or masters can participate in elite races to expand the bunch. Nevertheless, riders younger than 18 years old will not score UCI points and must not be taken into account in the analysis of the minimum number of participating nations and riders (**Article 3.8.003**). 18-year-olds junior riders will score UCI points in elite ranking. In any case, all riders must be included in the results.

For events organised as tournaments with an overall ranking, differing from the UCI regulated format (e.g. several Points Races held over multiple days), and in accordance with article 3.3.005, points will be awarded based on the tournament's final ranking. If several races of the same event are organised within a single competition and each has a separate ranking, the competition programme must clearly indicate which one will count towards the UCI ranking. This information must be communicated to the UCI Track Unit (track@uci.ch).

All new international competitions will be registered in Class 2 into the UCI Track International Calendar for one year of probation. From the second edition, the organiser will be allowed to request an upgrade to Class 1.

CLASS 1 COMPETITION

A competition registered in Class 1 will automatically obtain the Class 1 points, regardless of the participation criteria being met. Competitions or specific events won't be relegated that same year, ensuring more security to riders and organisers. A Class 1 competition will however have to respect the following requirements to keep its status the following year (further detailed in **article 3.8.003**):

4 PARTICIPATING NATIONS

The minimum number of nations is evaluated for each event of the competition registered on the UCI international calendar. In terms of points granted to riders, any events in the programme registered as Class 1, riders will be awarded points according to the scale provided for a **class 1** event.

However, if some events in the programme have **only 3 nations or less** at the start, the specific event or even the competition might be relegated in Class 2 or national the following year.

Warning: This analysis must be made on the basis of the riders participating in the specific category of the event only (for example a Scratch race Men Elite, nations and number of elite riders will be taken into account only).

EVENTS FOR MEN ELITE AND WOMEN ELITE

plus 1 other category to be chosen from Men or Women U23, Men or Women Junior, or Para cycling.

The requirement of events for **3 categories** to be organised within the competition's programme take into account all events organised, **even national event or those with one country represented at the start**. Different categories can be combined in one event. Nevertheless, the category of the majority of participants will be taken into account only. Participants belonging to another category must be included in the results but will not receive UCI points.

MINIMUM OF 5 CLASS 1 ELITE EVENTS(*events part of the World Championships programme in one category*).

The requirement of events takes into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

MINIMAL NUMBER OF RIDERS PER EVENT ELITE AND U23

In addition to the participating nations criteria, each event must have a minimal number of participants to fulfil the requirements.

- Sprint: 8 riders (**Article 3.2.031**)
- Keirin: 10 riders (**Article 3.2.135**)
- Bunch races: 15 riders
- Madison: 10 teams

CLASS 2 COMPETITION

Class 2 competitions and/or events must fulfil the following criteria:

3 PARTICIPATING NATIONS

The minimum number of nations is considered in each of the events of the competition registered on the UCI international calendar.

In terms of points granted to riders, any events in the programme where **at least 3 nations** are competing, riders will be awarded points according to the scale provided for a **class 2** event.

If some events in the programme have **between 1 to 2 nations** or an insufficient number of riders at the start, **no points will be awarded** to riders competing.

EVENTS FOR MEN ELITE OR WOMEN ELITE

Plus 1 other category to be chosen from Men or Women Elite, Men or Women U23, Men or Women Junior, or Para cycling.

The requirement of events for **2 categories** to be organised within the competition's programme take into account all events organised, **even national event or those with one country represented at the start**.

Different categories may be grouped together in the same event. However, the category of the majority of the participants will be taken into account only. Participants belonging to another category must appear in the results but will not receive UCI points.

MINIMUM OF 3 CLASS 2 ELITE EVENTS

(Event part of the World Championships programme in one category).

The requirement of events takes into account any event's type represented at the World Championships, regardless of the number of nations at the start of those events.

MINIMAL NUMBER OF RIDERS PER EVENT ELITE AND U23

In addition to the participating nations criteria, each event must have a minimal number of participants to fulfil the requirements.

- Sprint: 8 riders (**Article 3.2.031**)
- Keirin: 10 riders (**Article 3.2.135**)
- Bunch races: 12 riders
- Madison: 8 teams

OTHER ITEMS

REGIONAL GAMES

A UCI international commissaire is appointed to the competitions included on the calendar of the Regional Games. These competitions are subject to the payment of a calendar fee.

Regional games will be considered as Class 1 or Class 2 competitions. Points awarded depend on the number of participating national federations as stipulated in art. 3.3.010.

The general regulations for the organisation of Regional Games are stipulated in [Title 10 - Chapter 2 of the UCI Regulations](#).

The host National Federation is responsible for submitting the calendar application for each included discipline following approval by the relevant Continental Confederation or the responsible authority.

SIX DAYS RACES

When registering the competition, the organiser must indicate in the comments section of the third page of the registration whether the competition will follow the "Six Day Race" format, in accordance with the criteria set out in the UCI Regulations (article 3.2.227 to article 3.3.246).

To register a Six Day Race, the Madison event must be selected. Any additional events within the same competition that are not part of the "Six Day Race" format must be registered separately in the competition.

REMINDER: LATE ENTRIES (after 31 July)

Following the update of the UCI **Article 3.8.001ter**, late registrations will only be possible in Class 2. It is also reminded that to add a Class 2 competition to the UCI Track Calendar the deadline of 3 months shall apply (**Article 3.8.001ter**). As per the financial obligations, any modification (addition or removal of an event) shall be communicated 30 days before the competition, failing that it will still be possible to add events but the class of the event will be Class 2. The modification fees as per the Financial Obligations still apply.

SPECIFIC INSTRUCTIONS FOR THE UCI INTERNATIONAL MOUNTAIN BIKE CALENDAR

CALENDAR

As stated in **Article 4.1.011**:

International Mountain Bike races are registered on the International Calendar in accordance with the following classification:

- Olympic Games (OG)
No other international Mountain Bike Cross-country (XC) competition may be organised during the Mountain Bike competition of the Olympic Games.
- UCI World Championships (CM)
No other international Mountain Bike competition of the same format may be organised during the UCI Mountain Bike World Championships.
- UCI World Cup (WC)
No Hors Class (HC), UCI Mountain Bike Continental Series (CS) or Class 1 competition of the same format may be organised on the same continent on the same day as a UCI Mountain Bike World Cup competition.

The Continental Championships (CC) and National Championships (CN) in a format may not be organised during a World Cup competition in the same format.

- Masters World Championships (CMM)
- Continental Championships (CC)
No Hors Class (HC), UCI Mountain Bike Continental Series (CS) or Class 1 competition of the same format may be organised on the same continent on the same day as Continental Championships.
- UCI Continental Series (CS)
Upon consultation with the respective Continental Confederation, the UCI will appoint a certain number of competitions to be part of each UCI Mountain Bike Continental Series (CS) in accordance with the dedicated document published by the UCI.

The competition name must be UCI Mountain Bike Continental Series followed by the event name.

No Continental Series (CS) may be organised during the Mountain Bike World Championships, the UCI Mountain Bike World Cup or the Continental Championships of the same format on the same continent.

- Stage races
 - Competition Class: Hors Class (SHC) / Class 1 (S1) / Class 2 (S2)
 - No stage race Hors Class may be organised during the Mountain Bike competition of the Olympic Games, or the UCI Mountain Bike Cross-

country World or UCI Mountain Bike Cross-country Marathon World Championships, or UCI Mountain Bike Cross-country World Cup competitions in the concerned continent.

- No stage race, in Hors Class (HC) or Class 1, may be organised during the Continental Championships of the same format, on the concerned continent.
- One-day races
 - Class: Hors Class (HC) / Class 1 / Class 2 / Class 3
- UCI XCO Junior Series
The UCI will appoint a certain number of UCI XCO Junior Series competitions every year in accordance with the document published by the UCI.
- National Championships (CN)
National Championships cannot be run during the Mountain Bike competition at the Olympic Games, UCI World Championships or UCI World Cup competitions of the same format and cannot be run during Continental Championships of the same format on the concerned continent.

Cross-country Olympic (XCO) or Cross-country Short Track (XCC) National Championships cannot be incorporated in an International Mountain Bike competition.

For all other formats, in the event a National Championship is incorporated in an International Mountain Bike competition, a rider can only receive points once. The riders with the sporting nationality of the National Federation will receive the National Championships points according to their rank in the race (i.e. including all riders regardless of their sporting nationality) and other riders will receive the class event points according to their rank in the race.

A competition can include different formats (XCO/XCC/XCE/DHI/4X). **All categories of one format must be registered in the same class** (for example: all XCO categories in Class 1 and all DHI categories in Class 2 and XCE /XCC in Class 3).

CUPS / SERIES

A written authorisation must be requested from the UCI for the organisation of "Cups/Series" as per **Article 1.2.026** of the UCI Regulations.

A Mountain Bike "Cup/Series" will be comprised of no more than eight rounds.

HORS CLASS COMPETITION

A detailed technical guide for each Class HC competition must be presented to the UCI during the calendar registration process (**Article 4.1.011**). You can find the template of the technical guide by clicking on this [link](#).

NEW COMPETITION

A new competition may only be given Class 2 or Class 3 status in its first year. A detailed technical guide for each new event must be presented to the UCI during the calendar registration process (**Article 4.1.011**).

OTHER ITEMS

UCI MOUNTAIN BIKE WORLD SERIES TEAMS:

Race entry fees for competitions on the international calendar are waived for any rider belonging to a UCI MOUNTAIN BIKE WORLD SERIES TEAM. This applies only to the format in which the team has this status and does not apply to Stage Races, Eliminator (XCE) and Enduro competitions (EDR).

UCI MOUNTAIN BIKE WORLD SERIES TEAMS lists can be found on the UCI website by clicking on [this link](#).

CROSS-COUNTRY OLYMPIC - XCO

"UNDER 23" CATEGORY

Separate Under 23 XCO categories for men and women are mandatory for UCI World Championships, UCI World Cup, Continental Championships and UCI Mountain Bike Continental Series event types and may be organised for Hors Class (HC) and Class 1 events, in this case separate results must be submitted for both categories. During Class 2 and Class 3 XCO event types Under 23, men and women, will compete with the elite categories. As such no separate results must be submitted for the Under 23 categories at Class 2 and Class 3 XCO events (**Article 4.1.004**).

If an organiser ticks on the registration form the "Under 23" category (men & women), make sure that the organiser really intends to organise a separate "Under 23" event with a separate event, points scale and prize money.

UCI JUNIOR SERIES – XCO

Applications to host a round of the UCI Junior Series will be accepted from Class HC or Class 1 (priority will be given to Class HC).

If you request a UCI Junior Series-XCO, select the event type "XCO-JS" in the online form for the categories Men Junior and Women Junior.

The UCI will appoint the selected competitions in conjunction with the relevant confederation. Competitions that are not appointed will automatically be re-attributed the Class of other events taking place in the same competition. You can find more information on the UCI Junior Series by clicking on this [link](#).

UCI JUNIOR EVENTS – XCO

UCI XCO Junior events approved by the National Federation are included on the UCI Mountain Bike International Calendar as Junior category events. If you request a UCI XCO Junior event, fill in the category Men Junior / Women Junior on the registration form.

UCI CONTINENTAL SERIES

Upon consultation with the respective Continental Confederation, the UCI will appoint a certain number of events to be part of each Continental Series. You can find more information on the Continental Series by clicking on this [link](#).

CROSS-COUNTRY STAGE RACES – XCS

Specifications on stage race can be found in **Articles 4.2.066 to 4.2.080**.

Article 4.2.071 will be applied as follows:

4.2.071 - Duration and stages

Stage races are run over **at least four days**, with a maximum of nine days. Only one stage per day may be run.

In addition, the events must include at least one long distance stage that meet the minimum distance of a Cross-country Marathon event as **per Article 4.2.004**.

A detailed technical guide for each stage race must be presented to the UCI during the calendar registration process (**Article 4.1.011**).

In the technical guide of stage race it must be clearly mentioned if riders compete in a team or individually. The specific regulations of the stage race must be sent with the technical guide. You can find the template of the technical guide by clicking on this [link](#).

CROSS-COUNTRY ELIMINATOR - XCE

Apart from XCE World Championships and XCE World Cup, all other XCE competitions will be considered as Class 3 events as follows:

- Either as a race that is part of a XCO competition: in that case the registration fee will be an additional day to the XCO calendar fee as per the UCI financial obligations.
- Or a separate Class 3 XCE competition.

CROSS-COUNTRY SHORT TRACK – XCC

Apart from XCC World Championships, XCC Continental Championships and XCC National Championships, all XCC competitions will be considered as Class 3 events as follows:

- Either as a race that is part of the XCO event: in that case the registration fee will be an additional day to the XCO calendar fees as per the UCI financial obligations.
- Or a separate Class 3 XCC competition.

"UNDER 23" CATEGORY

Separate Under 23 XCO categories for men and women are mandatory for World Championships, World cups, Continental Championships. For other competitions no separate results must be submitted. (**Article 4.1.005**)

CROSS-COUNTRY MARATHON - XCM

XCM competitions will be considered as Class HC, Class 1 or Class 2 competitions.

ENDURO – EDR/E-EDR

Specifications on Enduro can be found in **Articles 4.5.001 to 4.5.020**. Enduro competitions will be considered as Class 3 events. Prize money is at the organiser's discretion but must at least equal that of a Class 3 competition, and have parity between men and women.

E-MOUNTAIN BIKE CROSS-COUNTRY AND E-ENDURO – E-XC AND E-EDR

Specifications on EPAC can be found in **Articles 4.8.001 to 4.8.005**. E-MTB competitions will be organised in the Cross-country (E-XC) and Enduro (E-EDR) formats only and will be considered as Class 3 events.

The characteristics and format of each competition will be determined in the technical guide for each event. A technical guide must be presented to the UCI during the registration process. You can find the template of the technical guide by clicking on this [link](#).

PUMP TRACK - PUM

As per **Articles 5.1.004 and 5.1.005**:

International Cyclo-cross competitions are registered on the UCI Cyclo-cross International Calendar in accordance with the following classification:

- UCI Cyclo-cross World Championships
- UCI Cyclo-cross World Cup
- UCI Masters Cyclo-cross World Championships
- Continental Championships
- National Championships
- Class 1
- Class 2

CATEGORIES

The main rules impacting the competition's categories will be published when this procedure is updated on 15 October 2026.

Following the UCI multi-year plan for Women Junior's development, a separate race for Women Junior will be mandatory for all Class 1 and Class 2 competitions (in addition to Men Elite, Women Elite and Men Junior, that are already mandatory races).

UCI commissaires have been informed on how to integrate a separate Women Junior race to a one-day Cyclo-cross competition's schedule. Do not hesitate to contact them or offroad@uci.ch if you need help on that topic.

We encourage national Cyclo-cross competitions' organisers to take attention to the following rules before considering a registration to the International or National Cyclo-cross Calendar, as per article 5.1.002:

- a rider ranked 21st to 50th of the most recently published Elite UCI Cyclo-cross ranking may not take part in national competitions in a country other than the federation of his sporting nationality.
- a rider ranked in the top 20 of the most recently published Elite UCI cyclo-cross ranking may not take part in any national competitions.

DEADLINES

Registration requests for the 2027-2028 UCI Cyclo-cross competitions must be communicated to the UCI before 15 December 2026.

NEW COMPETITION

A new competition may only be given Class 2 status in its first year. A detailed technical guide for each new competition must be presented to UCI during the calendar registration process. You can find the template of the technical guide by clicking on [this link](#).

CLASS 1 COMPETITION

The allocation of competition classes shall be carried out annually by the UCI Management Committee.

A competition will only be given or maintained Class 1 status if the previous season's races do not present any major organisational issues and following the UCI's approval. **(Article 5.1.004)**

No Class 1 competition may be held on the same day as a UCI Cyclo-cross World Cup round.

A Class 1 competition may be held on the day before or the day after a UCI Cyclo-cross World Cup round only with UCI's previous approval. **(Article 5.1.005)**

A Class 1 competition which would not respect the above mentioned will automatically get the Class 2 status for the next season. Exception for the competitions which were Class 1 in the preceding season and received the organisation of the National Championships during the current season.

As a reminder, during Class 1 competitions the double pit area is mandatory and must be equipped with separated and numbered boxes **(Article 5.1.028)**.

CLASS 2 COMPETITION

No Class 2 competition may be held on the same day as a Class 1 competition in the same country (for Europe) or in the same region (for USA).

SERIES

A written request must be done to the UCI for the organisation of a "Series" as per **Article 1.2.026** of the UCI Regulations. Furthermore, the following obligations must be respected:

- The Series must be organised or approved by their National Federation;
- A Cyclo-cross Series can count a maximum of eight rounds;
- A maximum of two Series by National Federation will be accepted.

2027-2028 DRAFT CALENDAR

The draft calendar of the 2027-2028 Cyclo-cross season will be published before the 31 October 2026. It will include the dates, the list of protected dates* and possibly the nations of the UCI Cyclo-cross World Cup rounds, the mandatory dates for the Continental Championships and the National Championships.

The reference dates are:

- 2027 Continental Championships: 06-07 November 2027
- 2028 National Championships: 08-09 January 2028 **
- 2028 UCI Cyclo-cross World Championships in Hoogerheide, the Netherlands 28-30 January 2028
- 2027 UCI Masters Cyclo-cross World Championships, location to be confirmed in October 2026, on: 04-05 December 2027

** As per article 5.1.004, the UCI will draw up a list of protected UCI Cyclo-cross World Cup rounds. The allocation of the protected status for a competition shall be based on an assessment of its relevance in terms of international development of the discipline of Cyclo-cross. For any competition applying for registration on the UCI Cyclo-cross International Calendar for the day of or the day prior to a competition with protected status, the UCI may render a decision of refusal, in accordance with article 1.2.012. par. 2 ii) and iii) of the UCI Regulations.*

*** The UCI can exceptionally grant a derogation from this mandatory date for meteorological reasons.*

CALENDAR

As stated in **Article 6.1.100**:

International BMX Racing competitions are registered on the UCI BMX Racing International Calendar in accordance with the following classification:

- **Olympic Games**
- **UCI BMX Racing World Championships**
No other international competition may be organised on the same dates as the UCI BMX Racing World Championships. No Hors Class, Class 1, Class 2 competition or Continental Championships may be organised on the weekend prior to the starting date of UCI BMX Racing World Championships.
- **UCI BMX Racing World Cup**
No other international competition may be organised on the same dates as a UCI BMX Racing World Cup round.
- **Continental Championships**
No other Hors Class, Class 1, Class 2 competition or National Championships on the same continent during the Continental Championships date may be organised.
Continental Championships are regulated in accordance with Part X of the UCI Regulations, "Continental Championships". Additionally, the Continental Confederation shall provide the bid procedure to each country in enough time for the countries to submit bids to host the Continental Championships. The bid procedure shall be available, at least, in either English or French.
- **Hors Class Competition**
No other Class 1, Class 2 competition or National Championships may be organised on the same date as a Hors Class competition on the same continent.
Competitions registered on the UCI BMX Racing International Calendar for the first time (new organiser, new venue, or both) are not eligible for Hors Class status.
The Continental Confederation must propose or otherwise approve all Hors Class competitions to be held within the continent concerned.
A maximum of six Hors Class competitions may be registered in any continent in each season.
In order to be awarded Hors Class status, the competition must have had sufficient numbers of riders entered in the Men Elite category in the season before the application for Hors Class status such that at least semi-finals were held.
For avoidance of doubt, Hors Class competitions are open to licence holders of all nationalities.

- **Class 1 International Competition**
There is no limitation on the number of Class 1 competitions that a National Federation may apply to hold.
- **Class 2 International Competition**
There is no limitation on the number of Class 2 competitions that a National Federation may apply to hold.
- **National Championships**
National Championships must be run on the first weekend of July (article 1.2.029); no other competitions may be registered on the UCI BMX Racing International Calendar on this weekend or in conflict with registered National Championships.

If the UCI provides a derogation of article 1.2.029 to permit a National Federation to register their National Championships outside of the mandatory dates in July, no other competition may be registered on the same continent on that date, likewise, if a competition on the same continent is already registered on the UCI BMX Racing International Calendar on the date proposed by the National Federation for their National Championships, this date will not be approved.
- **Regional Games**

The UCI has the final and sole authority to allocate any competition on the UCI BMX Racing International Calendar, and to resolve all disputes concerning date conflicts and event classifications for events registered on that calendar.

TECHNICAL GUIDE

A detailed technical guide for each competition must be presented to UCI during the calendar registration process as per Article 1.2.009. Note that a competition will not be registered on the UCI BMX Racing International Calendar and shall be considered not complete if we have not received the technical guide of the competition.

HORS CLASS COMPETITIONS

Hors Class competition applications must first be submitted to the Continental Confederations for approval. Continental Confederations will then forward approved applications to the UCI. CALENDAR

As stated in **Article 6bis.3.002**:

The UCI BMX Freestyle International Calendar shall consist of the following types of competitions:

- **UCI BMX Freestyle World Championships**
No other competition may be registered on the UCI BMX Freestyle International Calendar on the same dates as the UCI BMX Freestyle World Championships.
- **UCI BMX Freestyle World Cup**
No other competition may be registered on the UCI BMX Freestyle International Calendar on the same dates as any UCI BMX Freestyle World Cup round.
- **Continental Championships**
Only riders with the sporting nationality of a country within the Continental Confederation in question are permitted to enter that Continental Championships. No other Hors Class, Class 1, Class 2 competition or National Championships in the same continent may be registered on the UCI BMX Freestyle International Calendar on the Continental Championships date for that continent.
- **Hors Class Competition**
No Class 1, Class 2 competition or National Championships may be organised on the same date as an Hors Class competition on the same continent.

Competitions registered on the UCI BMX Freestyle International Calendar for the first time (new organiser, new venue, or both) are not eligible for Hors Class status.

Hors Class status can only be obtained subject to compliance with the following cumulative conditions and requirements:

- A detailed technical guide must be presented to the UCI during the calendar registration process. A template for such technical guide is provided by the UCI upon request;
 - The competition has been registered for at least the last three years on the UCI BMX Freestyle International Calendar;
 - At least 10 nations represented in the last edition of the competition;
 - A high level TV production taking into account the sporting aspect.
- **Class 1 Competition**
National Federations may apply for the registration of one or more Class 1 competitions on the UCI BMX Freestyle International Calendar within each calendar year.

- **Class 2 Competition**
National Federations may apply for the registration of one or more Class 2 competitions on the UCI BMX Freestyle International Calendar within each calendar year. Class 2 is open to registration of competitions which differ from the UCI Regulations in accordance with article 6bis.3.029.
- **National Championships**
Every National Federation has the possibility to register a single National BMX Freestyle Championships in Park and/or Flatland on the UCI BMX Freestyle International Calendar within each calendar year.

A separate competition must be held for National Championships and cannot be incorporated in another competition registered on the UCI BMX Freestyle International Calendar.
- **Regional Games**

IN GENERAL

The UCI BMX Freestyle International Calendar shall consist of the following event types:

- BMX Freestyle Park
- BMX Freestyle Flatland

All competitions registered on the UCI BMX Freestyle International Calendar shall hold, at least, the UCI categories identified in Article 6bis.2.002. Such competitions on the UCI BMX Freestyle International Calendar shall comply with the UCI Regulations for the UCI categories.

The UCI has the sole authority to allocate any competition on the UCI BMX Freestyle International Calendar.

- **UCI Trials World Cup**
No other Trials competition (World Championships, Continental Championships, National Championships, Hors Class, Class 1, World Youth Games) may be organised on the same dates as any UCI Trials World Cup round.
- **Continental Championships**
No other Trials competition (National Championships, Hors Class, Class 1, World Youth Games) may be organised on the same continent during the Continental Championships.
- **UCI Trials World Youth Games**
No other Trials competition (World Championships, World Cup, Continental Championships, National Championships) may be organised on the same dates as the UCI Trials World Youth Games.
- **National Championships**
No other Trials competition (World Championships, World Cup, Continental Championships, World Youth Games, Hors Class, Class 1) may be organised on the same dates as the National Championships. Further, the dates retained for National Championships are mandatory and set out as per Article 1.2.029.
- **Hors Class Competition**
No other Trials competition (World Championships, World Cup, Continental Championships, Hors Class, Class 1) may be organised on the same dates as a Hors Class competition. In the event of a conflict with another Hors Class or Class 1 competition at the same date, the UCI may grant a derogation, at its sole discretion, provided that the competitions in question do not take place in the same country.
- **Class 1 Competition**
No other Trials competition (World Championships, World Cup, Continental Championships, Hors Class, Class 1) may be organised on the same dates as a Class 1 competition. In the event of a conflict with another Hors Class or Class

1 competition at the same date, the UCI may grant a derogation, at its sole discretion, provided that the competitions in question do not take place in the same country.

- **UCI Para Cycling Road World Championships (CM)**
No other Para Cycling competition (CDM, CC, C1, C2, CN) may be organised on the weekend prior to or on the same dates as the UCI Para Cycling Road World Championships.
- **UCI Para Cycling Track World Championships (CM)**
No other Para Cycling competition (CDM, CC, C1, C2, CN) may be organised on the weekend prior to or on the same dates as the UCI Para Cycling Track World Championships.
- **UCI Para Cycling Road World Cup (CDM)**
No other Para Cycling competition (CM, CC, C1, C2, CN) may be organised on the same dates as the UCI Para Cycling Road World Cup.
- **Continental Championships (CC)**
No other Para Cycling competition (JR, C1, C2, CN) may be organised on the same continent during the Continental Championships.
- **Regional Games (JR)**
No other Para Cycling competition (CC, C1, C2, CN) may be organised on the same continent during the Regional Games.

Regional Games were introduced to the UCI International Para Cycling Calendar on 1 January 2026. Points attributed are the same as Continental Championships. In years when both the Continental Championships and Regional Games take place, points will only be awarded for the competition where athletes received the most points as stipulated in article 16.18.003 of the [UCI Regulations](#).

- **International competition (Class 1)**
International competition organised independently of the UCI. The UCI assigns an International Commissaire to Class 1 competitions.
- **International competition (Class 2)**
International competition organised independently of the UCI. The National Federation assigns a national Commissaire to Class 2 competitions.

- **National Championships (CN)**
National competition organised by National Federations independently of the UCI. The National Federation assigns a national Commissaire to CN competitions.
